1. We respect your privacy

- 1. Nicole Weber Consulting respects your right to privacy and is committed to safeguarding the privacy of our customers and website visitors.
- 2. We adhere to the Australian Privacy Principles contained in the Privacy Act 1988 (Cth) and to the extent applicable, the EU General Data Protection Regulation (GDPR).
- 3. "Personal information" is information we hold which is identifiable as being about you. This includes information such as your name, email address, identification number, or any other type of information that can reasonably identify an individual, either directly or indirectly.
- 4. This policy sets out how we collect and treat your personal information.

2. Collection of personal information

- 1. Nicole Weber Consulting will, from time to time, receive and store personal information you enter onto our website, provided to us directly or given to us in other forms.
- 2. You may provide basic information such as your name, phone number, address and email address to enable us to send information, provide updates and process your product or service order. We may collect additional information at other times, including but not limited to, when you provide feedback, when you provide information about your personal or business affairs, change your content or email preference, respond to surveys and/or promotions, provide financial or credit card information, or communicate with our customer support.

3. How we collect your personal information

1. - e. If you withhold your personal information, it may not be possible for us to provide you with our products and services or for you to fully access our website.
- f. Contact information from forms is used to send information to our website users. Website user contact information is also used to get in touch with them when necessary. Order forms are used to process your orders.
- g. Users may opt-out of receiving future mailings for non-transactional emails by clicking on the unsubscribe link provided in our emails.

5. Disclosure of your personal information

a. We may disclose your personal information to any of our employees, officers, insurers, professional advisers, agents, suppliers or subcontractors insofar as reasonably necessary for the purposes set out in this Policy. Personal information is only supplied to a third party when it is required for the delivery of our services.

- b. We may from time to time need to disclose personal information to comply with a legal requirement, such as a law, regulation, court order, subpoena, warrant, in the course of a legal proceeding or in response to a law enforcement agency request.
- c. We may also use your personal information to protect the copyright, trademarks, legal rights, property or safety of Nicole Weber Consulting, its customers or third parties.
- d. Information that we collect may from time to time be stored, processed in or transferred between parties located in countries outside of Australia. These may include, but are not limited to Nicole Weber Consulting
- e. If there is a change of control in our business or a sale or transfer of business assets, we reserve the right to transfer to the extent permissible at law our user databases, together with any personal information and non-personal information contained in those databases. This information may be disclosed to a potential purchaser under an agreement to maintain confidentiality. We would seek to only disclose information in good faith and where required by any of the above circumstances.
- f. By providing us with personal information, you consent to the terms of this Privacy Policy and the types of disclosure covered by this Policy. Where we disclose your personal information to third parties, we will request that the third party follow this Policy regarding handling your personal information.

6. General Data Protection Regulation (GDPR) for the European Union (EU)

- . Nicole Weber Consulting will comply with the principles of data protection set out in the GDPR for the purpose of fairness, transparency and lawful data collection and use.
- a. We process your personal information as a Processor and/or to the extent that we are a Controller as defined in the GDPR.
- b. We must establish a lawful basis for processing your personal information. The legal basis for which we collect your personal information depends on the data that we collect and how we use it.
- c. We will only collect your personal information with your express consent for a specific purpose and any data collected will be to the extent necessary and not excessive for its purpose. We will keep your data safe and secure.
- d. We will also process your personal information if it is necessary for our legitimate interests, or to fulfil a contractual or legal obligation.
- e. We process your personal information if it is necessary to protect your life or in a medical situation, it is necessary to carry out a public function, a task of public interest or if the function has a clear basis in law. We do not collect or process any personal information from you that is considered "Sensitive Personal Information" under the GDPR, such as personal information relating to your sexual

orientation or ethnic origin unless we have obtained your explicit consent, or if it is being collected subject to and in accordance with the GDPR.

f. You must not provide us with your personal information if you are under the age of 16 without the consent of your parent or someone who has parental authority for you. We do not knowingly collect or process the personal information of children.

7. Your rights under the GDPR

- . If you are an individual residing in the EU, you have certain rights as to how your personal information is obtained and used. Nicole Weber Consulting complies with your rights under the GDPR as to how your personal information is used and controlled if you are an individual residing in the EU
- a. Except as otherwise provided in the GDPR, you have the following rights: i.to be informed how your personal information is being used; ii.access your personal information (we will provide you with a free copy of it); iii.to correct your personal information if it is inaccurate or incomplete; iv.to delete your personal information (also known as "the right to be forgotten"); v.to restrict processing of your personal information; vi.to retain and reuse your personal information for your own purposes; vii.to object to your personal information being used; and

 - c. We may ask you to verify your identity before acting on any of your requests.

- a. We and our other group companies have offices and/or facilities in Australia. - b. The hosting facilities for our website are situated in Australia and Singapore. Transfers to each of these Countries will be protected by appropriate safeguards, these include one or more of the following: the use of standard data protection clauses adopted or approved by the European Commission which you
